• <u>2</u> Proofs of Residency for Cherry Hill from the <u>OWNER</u> of the property: *Property Tax Bill, Mortgage Statement, Current Utility Bills (i.e., PSE&G, Water, Sewer, Telephone, Cell Phone – NO CREDIT CARD BILLS), Financial Account Information, Employment Documentation, or any other business record or documentation issued by a government entity. They must be dated within the two months prior to your registration appointment.

** <u>PLUS</u>:

• <u>2</u> Proofs of Residency for Cherry Hill from the <u>TENANT</u>: *Current Utility Bills (i.e., PSE&G, Water, Sewer, Telephone, Cell Phone – NO CREDIT CARD BILLS), Financial Account Information, Employment Documentation, or any other business record or documentation issued by a government entity. They must be dated within the two months prior to your registration appointment.
