## **ANNUAL REQUIRED NOTICE**

August 15, 2024

Dear Parents, Teachers, Building Occupants, and Employee Organizations:

Federal Law requires the following annual notification.

In the past asbestos was used extensively in building materials because of its insulating, sound absorbing, and fire retarding capabilities. Virtually any building constructed before the late 1970s contained some asbestos. Intact and undisturbed asbestos materials generally do not pose a health risk. Asbestos materials, however, can be hazardous when, due to damage or deterioration over time, they release fibers. If the fibers are inhaled, they can lead to health problems, such as cancer and asbestosis.

In 1986, Congress passed the Asbestos Hazard Emergency Response Act (AHERA), which requires schools to be inspected to identify any asbestos containing materials. Suspected asbestos-containing building materials were located, sampled (or assumed) and rated according to condition potential hazard.

The law further requires asbestos management plans to be in place by July 1989. The Cherry Hill Township Public Schools developed plans, as required, which have been continually updated. The plans have several ongoing requirements: publish a notification on management plan available and the status of asbestos activities; educate and train it employees about asbestos and how to deal with it; notify short-term or temporary workers on locations of the asbestos containing building materials; post warning labels in routine maintenance areas where asbestos was previously identified or assumed; follow set plans and procedures designed to minimize the disturbance of asbestos containing building materials every (6) months to assure that they remain in good condition.

It is the intention of the Cherry Hill Township Public Schools to comply with all federal and state regulations controlling asbestos and to take whatever steps are necessary to ensure student and employees a healthy and safe environment in which to learn and work.
